#### 4. First-aid Measures

Take off all contaminated clothing immediately.

### 7. Handling and Storage

#### Precautions for safe handling

##### Protective measures:

Put on appropriate personal protective equipment. Avoid contact with used product. Do not reuse container.

##### Advice on general occupational hygiene:
